

WHEREFORE, I respectfully request that this motion for my admission *pro hac vice* be granted.



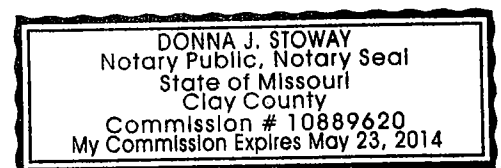
