**AT&T MISSOURI'S APPLICATION FOR APPROVAL OF
AMENDMENTS TO AN INTERCONNECTION AGREEMENT**

AT&T Missouri,¹ pursuant to Section 252(e) of the Telecommunications Act of 1996 ("the Act")² and 4 CSR 240-3.513(6)(C), respectfully submits this Application for Approval of two Amendments to the Interconnection Agreement ("Agreement") by and between AT&T Missouri and Level 3 Communications, LLC and requests that the Commission approve the Amendments.

In support of this Application, AT&T Missouri states:

1. AT&T Missouri is a Delaware corporation with its principal Missouri office at 909 Chestnut Street, Room 3558, St. Louis, Missouri 63101. It may be contacted at the regular and electronic mail addresses and telephone and facsimile numbers of its attorney, as set out under the signature block of this Application. AT&T Missouri is authorized to do business in Missouri³ and its fictitious name is duly registered with the Missouri Secretary of State.⁴ AT&T Missouri is a "local exchange telecommunications company" and a "public utility," and is duly authorized to provide

"telecommunications service" within the State of Missouri, as each of those phrases is defined in Section 386.020, RSMo 2000.

3. AT&T Missouri has no pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve retail customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of this Application.

4. AT&T Missouri does not have any annual report or assessment fees that are overdue in Missouri.

5. AT&T Missouri seeks approval of the Amendments submitted herewith, which have been signed by the parties. The Commission must approve the Amendments unless it determines that the Amendments (or any portions thereof) (1) discriminate against a telecommunications carrier not a party to the Amendment, or (2) the implementation of such Amendments is not consistent with the public interest, convenience, and necessity.⁵

6. AT&T Missouri states that the Amendments do not discriminate against a telecommunications carrier not a party to the Amendments. AT&T Missouri further states that implementation of the Amendments is consistent with the public interest,

convenience, and necessity. The purpose of the Amendment dated February 9, 2015 is to add a 911 trunking amendment to the current Agreement. The purpose of the Amendment dated March 4, 2015 is to add Entrance Facilities provisions to the Network Interconnection Methods Appendix in the current Agreement.

WHEREFORE, AT&T Missouri respectfully requests that the Commission approve the Amendments to the Interconnection Agreement between AT&T Missouri and Level 3 Communications, LLC.


