CENTURYTEL OF MISSOURI, LLC NOTICE OF AMENDMENT TO APPLICATION FOR REVIEW AND REVERSAL OF THE NORTH AMERICAN NUMBER PLAN ADMINISTRATOR'S DECISION

COMES NOW CenturyTel of Missouri, LLC ("CenturyTel") pursuant to Commission Rule 4 CSR 240-2.080, and for its Notice of Amendment to Application for Review and Reversal of the North American Number Plan Administrator's Decision respectfully states as follows:

1. On August 9, 2007, CenturyTel filed its verified Application for Review and Reversal of the North American Number Plan Administrator's Decision to Withhold Numbering Resources for the Warrenton, Wentzville, Defiance, Dardenne and Moscow Mills, Missouri Rate Centers pursuant to Commission Rules 4 CSR 240-37.040 and 4 CSR 240-2.060 and federal rule 4 C.F.R. 52.15(g)(3)(iv), initiating the above-referenced matter. Pursuant to the original Application, CenturyTel requests the Commission to review and reverse the North American Number Plan Administrator's ("NANPA") Decision to withhold numbering resources in the Warrenton, Wentzville, Defiance, Dardenne and Moscow Mills, Missouri Rate Centers and instruct NANPA to release the numbering resources necessary to meet the needs of CenturyTel's customers in the five specified exchanges.

- 2. On August 14, 2007, the Commission issued its Order Directing Notice, Establishing Time for Filing Requests to Intervene, and Establishing Time for Filing Recommendations in this matter. No party has filed an application to intervene in this proceeding.
- 3. Pursuant to discussions with the Staff of the Commission, CenturyTel hereby notifies the Commission and Staff that it is amending the relief requested in this matter as specified herein.
- 4. In CenturyTel's original Application, it requested two blocks of 1,000 numbers within the existing MCA NXX code of 636-887 assigned to the Wentzville, Missouri rate center. CenturyTel hereby amends its request for the Wentzville, Missouri rate center to one block of 1,000 numbers within the existing MCA NXX code of 636-887 assigned to the Wentzville, Missouri rate center.
- 5. In CenturyTel's original Application, it requested one block of 1,000 numbers within a new non-MCA NXX code to be assigned to the Warrenton, Missouri rate center. Upon further investigation by Staff of the Commission and subsequent confirmation by CenturyTel, it was discovered that there are a few existing 1,000 blocks available in the non-MCA NXX code of 636-235 assigned to the Warrenton rate center. CenturyTel hereby amends its request for the Warrenton, Missouri rate center to request assignment of one block of 1,000 numbers within the existing non-MCA NXX code of 636-235 assigned to the Warrenton, Missouri rate center.
- 6. Further, CenturyTel amends its original Application pursuant to 4 CSR 240-37.040(1)(A)2, by submitting a copy of CenturyTel's current number resource utilization level, Federal Communications Commission Form U1 of Form 502 for the Warrenton, Wentzville,

Defiance, Dardenne and Moscow Mills, Missouri rate centers, attached hereto, and incorporated herein by reference, as **Exhibit H**.

Wherefore, CenturyTel respectfully submits its Notice of Amendment to its previously filed Application for Review and Reversal of the North American Number Plan Administrator's Decision to Withhold Numbering Resources for the Warrenton, Wentzville, Defiance, Dardenne and Moscow Mills, Missouri Rate Centers.
