## STAFF RECOMMENDATION

**COMES NOW** the Staff of the Missouri Public Service Commission in the above-captioned matter and files its Staff Recommendation as set forth in the accompanying Memorandum (which is incorporated herein by reference) concerning the May 17, 2017, tariff filing by Missouri Gas Energy ("MGE" or "Company"), a division of Laclede Gas Company, and further states as follows:

1. On May 17, 2017, MGE filed a tariff sheet with a requested effective date of June 1, 2017, to reflect a change in MGE's Purchased Gas Adjustment ("PGA") factor as a result of estimated changes in the cost of natural gas that have occurred since it established its existing PGA rates last November and inclusion of a PGA Filing Adjustment Factor ("FAF") adjustment. As explained in the accompanying Memorandum, this filing will increase the firm sales PGA factor to \$.56934 per one-hundred cubic feet (Ccf), from the current PGA factor of \$.49492 per Ccf. This represents an increase of \$.07442.

2. Case No. GR-2017-0300, under which these changes were filed, was established to track the Company's PGA factors to be reviewed in its 2016-2017 Actual Cost Adjustment ("ACA") filing. Case Nos. GR-2016-0225 and GR-2015-0203 were established to track the Company's PGA factors to be reviewed in its 2015-2016 and

2014-2015 ACA filings, respectively. This rate change should be implemented on an interim basis, subject to refund, pending final Commission decisions in Case Nos. GR-2017-0300, GR-2016-0225, and GR-2015-0203.

3. Staff has verified that the Company has filed its annual report and is not delinquent on any assessment. Staff is not aware of any other matter before the Commission that affects or is affected by this filing except for the cases mentioned above.

4. As explained in the accompanying Memorandum, Staff has reviewed this filing and has determined that it was calculated in conformance with MGE's PGA Clause. Staff is of the opinion that good cause for approval of this tariff sheet on less than thirty (30) days' notice is demonstrated by MGE's Commission-approved PGA clause allowing for ten (10) business days' notice for PGA change filings.

WHEREFORE, Staff recommends the Commission issue an order approving the following tariff sheet as filed on May 17, 2017, on an interim basis, subject to refund:

**DATE:** May 25, 2017

On May 17, 2017, Missouri Gas Energy (MGE or "Company"), a division of Laclede Gas Company of St. Louis, Missouri, filed a tariff sheet requesting an effective date of June 1, 2017. This tariff sheet was filed to reflect a change in MGE's Purchased Gas Adjustment (PGA) factor as a result of estimated changes in the cost of natural gas that have occurred since it established its existing PGA rates last November. The filing also includes a "PGA Filing Adjustment Factor" (FAF) adjustment that increases the rate by \$0.05 per Ccf pursuant to Tariff Sheet No. 15.

This filing will increase the firm sales PGA factor to \$.56934 per one-hundred cubic feet ("Ccf"), from the current PGA factor of \$.49492 per Ccf. This represents an increase of \$.07442.

Case No. GR-2017-0300, under which these changes were filed, was established to track the Company's PGA factors to be reviewed in its 2016-2017 Actual Cost Adjustment (ACA) filing. Case Nos. GR-2016-0225 and GR-2015-0203 were established to track the Company's PGA factors to be reviewed in its 2015-2016 and 2014-2015 ACA filings, respectively. This rate change should be implemented on an interim, subject to refund status pending final Commission decisions in ACA Case Nos. GR-2017-0300, GR-2016-0225, and GR-2015-0203.

Staff has reviewed this filing and has determined that it was calculated in conformance with MGE's PGA Clause. Staff is of the opinion that good cause for approval of this tariff sheet
