On September 29, 2017, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities filed tariffs that would implement a general rate increase for its natural gas service. The Missouri Department of Economic Development, Division of Energy applied to intervene on October 18. More than ten days have passed since that application to intervene was filed and no one has responded to the application.

The Commission finds that allowing the Division of Energy to intervene will serve the public interest. Therefore, in accordance with Commission Rule 4 CSR 240-2.075(3), the Commission will grant the application to intervene.

**THE COMMISSION ORDERS THAT:**

1. The Missouri Department of Economic Development, Division of Energy's Application to Intervene is granted.
