**ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION  
AND SETTING TIME FOR RESPONSES**

On October 18, 2018, Union Electric Company d/b/a Ameren Missouri filed tariff sheets reflecting changes in the company's Purchased Gas Adjustment Clause. The tariff sheets bear a November 1, 2018 effective date.

In consideration of the effective date, the Commission will direct the Staff of the Missouri Public Service Commission (Staff) to file a recommendation on an expedited schedule. The Commission will also establish a deadline for any other entity to file a response to the tariff sheets or Staff's recommendation.

**THE COMMISSION ORDERS THAT:**

1. No later than October 25, 2018, the Staff of the Missouri Public Service Commission shall file a recommendation with regard to the tariff sheets filed by Union Electric Company d/b/a Ameren Missouri in Tariff File No. YG-2019-0068.
2. Any other entity wanting to comment on the tariff sheets or respond to Staff's recommendation shall do so no later than October 29, 2018.

3. This order shall be effective when issued.
