**COMES NOW** Kansas City Power & Light Company (“KCP&L”) and KCP&L Greater Missouri Operations Company (“GMO”) (collectively, the “Company”), and in response to the Order Directing Filing issued on August 18, 2010, hereby states as follows:

1. On August 6, 2010, the Commission Staff (“Staff”) filed the “Construction Audit and Prudence Review Iatan 1 Environmental Upgrades (AQCS) for Costs Reported as of April 30, 2010 Missouri Public Service Commission Staff Report” in Case Nos. ER-2010-0355 and ER-2010-0356 (“Staff Report”). Staff filed the Staff Report as being Highly Confidential and requested that the Company identify which portions of the Staff Report that the Company believes should be designated highly confidential, proprietary or public.
