ORDER CANCELING CERTIFICATES OF SERVICE AUTHORITY

Issue Date: December 21, 2021 Effective Date: January 20, 2022

On December 6, 2021, Delta Communications, L.L.C. d/b/a Clearwave Communications (Clearwave), filed a letter requesting its certificate of service authority, and any tariffs that may be on file with the Commission, be cancelled. Clearwave stated that it had no Missouri customers and no longer needs its certificate in Missouri. The Commission granted Clearwave certificates of service authority to provide interexchange and non-switched local exchange telecommunication service in the State of Missouri in File No. LA-2002-1075, on December 10, 2002.

On December 7, 2021, the Commission ordered its Staff to file a recommendation. Staff filed its recommendation on December 9, 2021, indicating that Clearwave's request was in compliance with 20 CSR 4240-28.011(3) regarding voluntary cancellation of certificates of service. Staff recommended that Clearwave's certificate be canceled. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." Based on the company's request,

and Staff's recommendation, the Commission finds that the certificate of service authority granted to Clearwave shall be canceled.

THE COMMISSION ORDERS THAT:

- 1. The certificate of authority to provide interexchange and non-switched local exchange telecommunications services granted to Clearwave Communications, in File No. LA-2002-1075 is canceled.
 - 2. This order shall become effective on January 20, 2022.
 - 3. This case may be closed on January 21, 2022.
