Re: The following Proposed Amendment to Rules concerning the Code for Modular Units; to reflect changes in code editions; Case # MX-2000-443: Rule #CSR 240-123.080

Dear Mr. Roberts:

The Missouri Association of Code Administrators (MACA), BOCA Charter Chapter # 26, representing over 130 jurisdictions in the State of Missouri, has the following comments concerning the above referenced proposed amendment to rules.

Since 2000, there has been only one family of codes published. All three of the major code groups have combined into one family of codes. A large portion of the jurisdictions in the State of Missouri have adopted or are in the process of adopting the new 2000 International Codes. See list attached.

MACA recommends that Section (3) subsection (A) and (B) be combined into one Section (3). Section (3) would read thus:

- (3) The structure shall be manufactured in accordance with and meet the requirements of the following International Codes: International Building Code/2000; International Plumbing Code/2000; International Fuel Gas Code/2000, and National Electric Code NFPA 70, 1999.
- (4) All modular units shall comply with the International Energy Conservation Code/2000.

Enclosed find two attachments. One is entitled, "Advantages of the International Codes". The second one is, "What's being said about the 2000 International Codes". You will find endorsements on both pages.

MACA believes it would further simplify the construction industry if all jurisdictions would adopt the International Codes as soon as possible. There would not be the confusion related to jurisdictional and regional differences that now exist.

Therefore, MACA asks the Commission to seriously consider adopting the International Codes as listed above.
