Pursuant to Chapter 22 of the regulations of the Missouri Public Service Commission ("Commission") and the Order Approving Stipulation and Agreement and Accepting 2006 Integrated Resource Plan issued April 12, 2007 in Case No. EO-2007-0008, Kansas City Power & Light Company ("KCPL") respectfully submits with this letter information in compliance with the Commission's Electric Utility Resource Planning (sometimes referred to as the "integrated resource plan" or "IRP") reporting requirements.
