Dear Judge Woodruff:

Algonquin Water Resources of Missouri, LLC d/b/a Liberty Utilities, a water and sewer utility regulated by the Missouri Public Service Commission, will now be operating under the name **Liberty Utilities (Missouri Water) LLC d/b/a Liberty Utilities**.

Liberty Utilities (Missouri Water) LLC d/b/a Liberty Utilities respectfully requests that the Commission recognize its name change. Pursuant to Commission Rule 4 CSR 240-2.060(5):

(A) The old name is Algonquin Water Resources of Missouri, LLC d/b/a Liberty Utilities and the new name is Liberty Utilities (Missouri Water) LLC d/b/a Liberty Utilities;

(B) Enclosed for reference are Liberty Utilities (Missouri Water) LLC's Amended Articles of Organization issued by the Missouri Secretary of State (**Appendix A**) reflecting the change in name of the limited liability company, and Liberty Utilities' fictitious name registration (**Appendix B**); and


