ORDER APPROVING AMENDMENT TO INTERCONNECTION AGREEMENT

Issue Date: July 15, 2022 Effective Date: August 14, 2022

This order approves an amendment to a negotiated Interconnection Agreement between the parties filed by Southwestern Bell Telephone Company, d/b/a AT&T Missouri.

On May 20, 2022, AT&T Missouri filed an application with the Commission for approval of an amendment to its negotiated Interconnection Agreement with Aureon Communications, L.L.C. under the provisions of the Federal Telecommunications Act of 1996. AT&T Missouri is certificated with the Commission as an incumbent local exchange carrier. Aureon Communications, L.L.C. is certificated with the Commission as an interexchange company and a competitive local exchange carrier.

Although Aureon Communications, L.L.C. is a party to the Agreement, it did not join in the application. On June 1, 2022, the Commission issued an order making Aureon Communications, L.L.C. a party in this case and directing any party wishing to request a hearing to do so no later than June 16, 2022. No requests for hearing were filed.

Under Section 252(e) of the Act, any Interconnection Agreement adopted by negotiation must be submitted to the Commission for approval. The Commission may reject an Agreement if it finds that the Agreement is discriminatory or that it is not consistent with the public interest, convenience and necessity.

On June 30, 2022, the Staff of the Commission filed a recommendation. Staff recommends that the Agreement as amended be approved and notes that the Agreement as amended meets the limited requirements of the Act in that it is not discriminatory toward nonparties and is not against the public interest.

The Commission has considered the application, the supporting documentation, and Staff's recommendation. Based upon that review, the Commission finds that the Agreement as amended meets the requirements of the Act in that it does not discriminate against a nonparty carrier and implementation of the Agreement as amended is not inconsistent with the public interest, convenience and necessity.

The application represents that the applicant has not had contact with the Office of the Commission about any substantive issue connected to the filing within 60 days before filing the application. On the basis of that representation, for good cause shown, the Commission will waive application of the pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1).

THE COMMISSION ORDERS THAT:

- 1. The amendment to the Interconnection Agreement between AT&T Missouri and Aureon Communications, L.L.C., filed on May 20, 2022, is approved.
 - 2. This order shall become effective on August 14, 2022.
 - 3. This file may be closed on August 15, 2022.
