**STAFF RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission and submits its  
*Recommendation* as follows:

1. On 11/23/2022, pursuant to 20 CSR 4240-28.013(2)(B), Embarq Missouri, Inc. d/b/a/ CenturyLink filed with the Public Service Commission its *Application for Approval of the Resale Forbearance Amendment to the Interconnection Agreement* between itself and Metropolitan Telecommunications of Missouri, Inc., d/b/a/ MetTel, under the provisions of the Federal Telecommunications Act of 1996.

2. 47 USC 252(e)(2) (2022) provides that a state commission may reject an interconnection agreement adopted by negotiation only if the agreement discriminates against a telecommunications carrier not a party to it or its implementation is not consistent with the public interest, convenience, and necessity.

3. In lieu of a Memorandum, Staff hereby states that the Interconnection Agreement does not discriminate against telecommunications carriers not parties to it, nor is its implementation inconsistent with the public interest, convenience or necessity. A copy of the Agreement was filed with the Application. CenturyLink is certified with the Commission as incumbent local exchange carrier (ILEC). MetTel is certificated with the Commission as a competitive local exchange carrier (CLEC).

**WHEREFORE,** Staff recommends the Commission approve the Application and grant such other and further relief as the Commission finds appropriate under the circumstances.
