
Dear Ms. Dale:

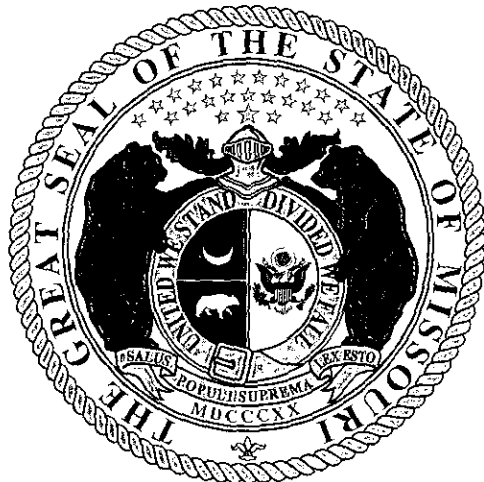


