ORDER CANCELING AUTHORITY

Issue Date: July 24, 2023

Effective Date: August 23, 2023

On March 24, 2023, the Staff of the Commission (Staff) filed a motion asking the Commission to cancel the certificates of service authority of MGM Interconnect, LLC (MGM or the Company) to provide basic local exchange, interexchange, and non-switched local exchange telecommunications services in Missouri.

The Commission granted MGM authority to provide basic local exchange, intrastate interexchange and non-switched local exchange telecommunications services Case No. LA-2020-0029.

Staff's motion states that MGM failed to submit an annual report due to the Commission for calendar years 2019, 2020, and 2021. Staff recommended that the Commission cancel the Company's certificate of service authority and registration.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." The Commission issued notice and allowed time to request a hearing. The Company has not responded.

Based on Staff's motion, the Commission finds that the certificate of service authority granted to MGM shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificates of service authority to provide basic local exchange, intrastate interexchange and non-switched local exchange telecommunications services granted to MGM in Case No. LA-2020-0029 is canceled.
2. This order shall become effective on August 23, 2023.
3. This case may be closed on August 24, 2023.
