**ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF**

This order cancels the certificate of service and accompanying tariff of World Communications Satellite Systems, Inc.

On December 13, 2004, the Staff of the Missouri Public Service Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of World Communications. Staff indicates that the website of the Missouri Secretary of State's Office lists the company as administratively dissolved for failure to maintain a registered agent as of November 12, 2004. Staff also states that a letter concerning the filing of World Communications' 2003 annual report was returned to the Commission on April 27, 2004. In addition, the company's Fiscal Year 2005 statement of revenue form was also returned as undeliverable on March 8, 2004. Staff also reported that the telephone number for the company president has been disconnected and Staff has no means of contacting the company.

Staff reports that the Office of the Clerk of the Virginia State Corporation Commission terminated the company as of August 31, 2004. Staff reports that the Federal Communications Commission has an unpaid forfeiture order in the amount of \$560,000 against the company for engaging in the practice of slamming. Staff also reports that the

Minnesota Public Utility Commission and the Wyoming Public Service Commission have each canceled the company's certificates to operate. Staff indicates that it has recorded 20 informal complaints against the company, all of which are considered closed and that the Missouri Attorney General's Office settled one complaint for slamming against the company in February of 2004. Finally, Staff states that the company owes an estimated assessment to the Commission in the amount of \$626.94.

Staff believes that the assessment amount is uncollectible, and that no more State of Missouri resources should be expended on trying to collect from this company. Staff, therefore, requests that World Communications's certificate and tariff be canceled.

Staff served its motion on the last known address of the company as found in the Commission's Electronic Filing and Information System (EFIS), the last address reported to the Commission in the company's 2002 Annual Report, and the company's registered agent as listed by the Missouri Secretary of State's Office. No response to Staff's motion was received.

World Communications was granted a certificate of service authority to provide interexchange telecommunications services with the approval of its tariff, M.P.S.C. No. 1, in Case No. TA-2002-7.

Under Section 392.410, RSMo Supp. 2003, the Commission has the authority to cancel a telecommunications corporation's certificate. After reviewing Staff's motion, the Commission determines that this company is no longer in business in the state. Therefore, the Commission finds that the certificate of service authority granted to World Communications, along with the accompanying tariff, should be canceled.

To ensure that the company has had every opportunity to respond, the Commission will require its Data Center to serve this order upon the addresses for the company as listed in Staff's certificate of service.

**IT IS THEREFORE ORDERED:**

1. That the certificate of service authority granted to World Communications Satellite Systems, Inc., in Case No. TA-2002-7 is canceled.

2. That the accompanying tariff, M.P.S.C. No. 1, filed by World Communications Satellite Systems, Inc., is canceled.

3. That the Data Center of the Commission shall serve a copy of this order on the following:

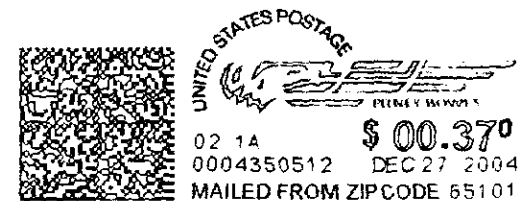
