**LIST OF ISSUES**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its *List of Issues* states as follows:

1. On November 14, 2008, Jerry and Sharon West (“Applicants”) filed a *Formal Complaint* with the Commission seeking approval to allow Cuivre River Electric Cooperative (“CREC”) to be the permanent electric service provider to their property.

2. On December 19, 2008 Union Electric Company d/b/a AmerenUE (“AmerenUE”) filed an *Answer* to the *Complaint*.

3. On May 4, 2009, AmerenUE, CREC, Applicants and Staff attended a Commission scheduled prehearing conference.

4. On May 6, 2009 the Commission ordered the parties to file a report identifying any remaining issues. The Commission also ordered that the parties file a list of their conflict dates during the month of June.

5. On May 19, 2009 WIK, L.L.C (“WIK”) filed a *Motion to Intervene* asserting it is the owner of a portion of the property that is the subject of the *Complaint*.

6. On May 20, 2009, Staff filed a *Motion for Extension* until May 29, 2009 to file the list of remaining issues. The Commission granted this request on May 21, 2009.

7. AmerenUE, CREC, Applicants, WIK and Staff (collectively referred as “the Parties”) have conferred and agreed upon what are the remaining issues:

- a. Does the Commission have the authority to order a change of supplier of electricity to the new structures?
- b. If the Commission does have authority to decide this issue, should they order a change of supplier?

8. The parties continue to talk among themselves and there may be further refinements of the statement of issues.

**WHEREFORE**, Staff respectfully submits the Parties list of issues.
