<u>STAFF'S RESPONSE IN OPPOSITION TO OPC'S MOTION TO REJECT</u> <u>TARIFF FILING AND MOTION FOR DIRECTED VERDICT</u>

COMES NOW Staff of the Missouri Public Service Commission (Staff) and respectfully submits as follows:

1. On May 1, 2006, Missouri Gas Energy (MGE) filed its Natural Gas Increase

Request with the Missouri Public Service Commission (Commission).

2. On August 17, 2006, the Office of the Public Counsel (OPC) filed its Motion

to Reject Tariff Filing and Motion for Directed Verdict (Motion).

3. Staff believes that a clear reading of the relevant statutes and rules show that OPC's Motion should be overruled.

4. The first question is what did MGE file in its tariffs on May 1, 2006 regarding MGE's Infrastructure System Replacement Surcharge (ISRS). Attached hereto as Attachment A is SHEET No. 10. This document shows that MGE clearly did not reset the ISRS to zero as OPC opines is required at the beginning of a rate case.

5. Staff agrees that MGE did not file tariffs resetting the ISRS to zero at the BEGINNING of the case. Staff, however, does not agree that MGE was required to file tariffs resetting the ISRS to zero at the BEGINNING of the case.

6. Section 393.1015.6(1) provides as follows:

6. (1) A gas corporation that has implemented an ISRS pursuant to the provisions of sections 393.1009 to 393.1015 shall file revised rate schedules to reset the ISRS to zero when new base rates and charges become effective for the gas corporation following a commission order establishing customer rates in a general rate proceeding that incorporates in the utility's base rates subject to subsections 8 and 9 of this section eligible costs previously reflected in an ISRS.

7. Courts reviewing statutes ascertain the legislative intent from the language used and to give effect to the words based on their plain and ordinary meaning. *Johnson v. Missouri Department of Corrections*, 166 S.W.3d 110, 111 (Mo. App. 2005). The legislature is presumed to have intended what the statute says and when the legislative intent is apparent from the words used and no ambiguity exists, there is no room for statutory construction. (Id. at 112).

8. By the clear terms of this statute, MGE's obligation to file revised rate schedules to reset the ISRS to zero has not yet arisen. That specific obligation does not arise until AFTER a Commission order establishing customer rates in a general rate proceeding. Accordingly, no change in the ISRS tariff sheet is required and therefore OPC's reliance on Commission Rules such as 4 CSR 240-2.065(1) is misplaced.

9. Accordingly, MGE did not violate any legal provision by filing the tariffs that it did regarding ISRS. In fact, the ISRS remains in effect until the Commission issues its Report and Order in this case. Section 393.1015.6(1).

10. For the foregoing reasons, Staff does not agree with OPC's Motion and it should be overruled for the legal reasons set out above.

WHEREFORE, Staff respectfully submits OPC's Motion should be overruled.
