ORDER SETTING ADDITIONAL LOCAL PUBLIC HEARING

On April 9, 2007, the Commission issued an order setting six local public hearings in this case. Since that time, the Commission has received comments indicating consumer interest in an additional local public hearing, in St. Charles, Missouri. The Commission has considered the matter and will hold a local public hearing in St. Charles as set out below.

Laclede Gas Company will be directed to notify the customers in its St. Charles County service area of this hearing as set out below. Because the Commission has another hearing set at the same location later that day, and the setting of these hearings on the same date will save considerable state resources, the Commission finds that good cause exists to set this hearing on less than ten-days' notice.

IT IS ORDERED THAT:

1. The Commission shall hold a local public hearing on Tuesday, June 12, 2007, from 12:00 p.m. until all persons who wish to testify have done so, in Room 116 of the St. Charles Administration Building, 201 North Second Street, St. Charles, Missouri. This building meets accessibility standards required by the Americans with Disabilities Act. Anyone needing additional accommodations to participate in the public hearing should call

the Public Service Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711 prior to the hearing.

2. Members of the Commission's Staff will be available to answer questions from the public from 11:30 a.m. to 12:00 p.m.

3. As soon as practicable, Laclede Gas Company shall place advertisements in the newspapers of general circulation in its St. Charles County, Missouri service territory of the date, time, and location of the local public hearing similar to the notice provided for the other public hearings.

4. The Data Center of the Missouri Public Service Commission shall serve a copy of this order on the county commission of St. Charles County, Missouri, and to the mayors of the cities of O'Fallon, St. Peters, Lake Saint Louis, and St. Charles, Missouri.

5. The Public Information Office of the Missouri Public Service Commission shall send a copy of this order to members of the General Assembly and to the media in St. Charles County, Missouri.

6. This order shall become effective on June 5, 2007.
