ORDER APPROVING INTERIM RATES

Issue Date: October 26, 2011 Effective Date: November 1, 2011

On October 17, 2011, Union Electric Company, d/b/a Ameren Missouri filed tariff sheets proposed to become effective November 1, 2011. The tariff sheets reflect a change in Ameren Missouri's Purchased Gas Adjustment (PGA) factor as a result of estimated changes in the cost of natural gas for the 2011-2012 winter season.

Ameren Missouri operates two service areas in Missouri. For the Rolla system, Ameren Missouri's filing will increase the PGA factor to \$0.8901 per hundred cubic feet (Ccf), from the current PGA factor of \$0.8400 per Ccf. For its non-Rolla service area, Ameren Missouri's filing will increase the PGA factor to \$0.7500 per hundred cubic feet (Ccf) from the current PGA factor of \$0.7300 per Ccf.

The Commission's Staff filed its recommendation on October 21. Staff recommends the rates be approved on an interim basis, subject to refund pending final Commission decision in this case.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation.

The Commission finds that the proposed tariff sheets conform to Ameren Missouri's

Commission-approved PGA Clause. In addition, because Ameren Missouri's PGA clause allows for PGA change filings to take effect on 10-days' notice, good cause has been shown pursuant to Section 393.140(11), RSMo 2000, to permit the tariff to become effective on less than 30-days notice. The Commission concludes that the proposed tariff sheets should be approved to become effective on November 1, 2011, on an interim basis, subject to refund, pending final Commission decision in this case.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheets filed on October 17, 2011, by Union Electric Company, d/b/a Ameren Missouri, assigned Tracking Number YG-2012-0167, and bearing an effective date of November 1, 2011, are approved on an interim basis, subject to refund, pending final Commission decision in this case. The tariff sheets approved are:
