I do hereby certify that the attached is an accurate and complete copy of the proposed rescission lawfully submitted by the Missouri Public Service Commission.

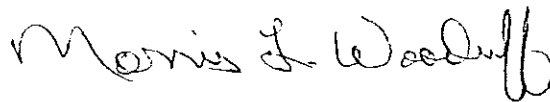

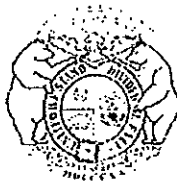

PURPOSE: This rule is being rescinded in its entirety because it is no longer necessary.

*AUTHORITY: section 700.455, RSMo Supp. 1987. * Original rule filed Nov. 8, 1985, effective Feb. 24, 1986.*
