Issue Date: January 26, 2017 Effective Date: January 26, 2017 On December 12, 2016, the Staff of the Commission filed a recommendation and memorandum indicating Staff has reviewed the 2014-2015 Actual Cost Adjustment (ACA) filing of Union Electric Company d/b/a Ameren Missouri. Staff proposed no financial adjustments to Ameren Missouri's ACA balances, but offered non-financial recommendations regarding the company's policies. The Commission directed Ameren Missouri to respond to Staff's recommendations, and the company did so on January 26, 2017.

Before acting to resolve Ameren Missouri's actual cost adjustment filing, the Commission will direct Staff to indicate whether it is satisfied with Ameren Missouri's response and whether it is now appropriate for the Commission to establish the final balances for Ameren Missouri's 2014-2015 ACA.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall reply to Union Electric Company, d/b/a Ameren Missouri's Response to Staff Recommendation no later than February 9, 2017. 2. This order shall be effective when issued.
