**ORDER APPROVING TARIFF**

Issue Date: April 29, 2015

Effective Date: May 1, 2015

On April 16, 2015, Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”) filed tariff sheets proposed to become effective May 1, 2015. The tariff sheets reflect changes in Ameren Missouri’s Purchased Gas Adjustment (“PGA”) as a result of estimated changes in the cost of natural gas. The changes in the PGA factors applicable to Ameren Missouri’s service areas will decrease the PGA factor, for both firm and interruptible sales customers, and leave unchanged the transportation PGA factors.

The Commission’s staff filed its recommendation on April 27, 2015. Staff recommends that the rates be approved on an interim basis, subject to refund, pending final Commission decisions in the following files:

- This File No. GR-2015-0271, which tracks the Company’s PGA factors to be reviewed in its 2014-2015 ACA filing; and
- File No. GR-2014-0238, which tracks the Company’s PGA factors to be reviewed in its 2013-2014 ACA filing.

The Commission has reviewed the proposed tariff sheets and Staff’s recommendation.

The Commission independently finds and concludes that the proposed tariff sheets conform to Ameren Missouri's Commission-approved PGA Clause. In addition, Ameren Missouri's PGA Clause allows for PGA filings to take effect on ten days' notice, which shows good cause under Section 393.140(11), RSMo 2000, for the tariff to become effective on less than 30 days' notice. Therefore, the Commission will approve the tariff to become effective on May 1, 2015, on an interim basis as described above.

**THE COMMISSION ORDERS THAT:**

1. The proposed tariff filed on April 16, 2015 by Union Electric Company d/b/a Ameren Missouri Gas Company, assigned tracking no. JG-2015-0304 and bearing an effective date of May 1, 2015, is approved on an interim basis as described in the body of this order.
