Dear Judge Roberts:

On July 21, 2004, XO Missouri, Inc. ("XO Missouri"), Allegiance Telecom of Missouri, Inc. ("ALGX Missouri") and XO Communications Services, Inc. ("XOCS"), by their attorneys, filed an Application regarding an internal corporate reorganization whereby XO Missouri and ALGX Missouri would be merged into a single operating subsidiary in Missouri - XOCS. XOCS would provide service to the existing customers of XO Missouri and ALGX Missouri in the State of Missouri. This Application was approved by the Missouri Public Service Commission ("Commission") on October 28, 2004. This letter is to advise the Commission that the transactions that were the subject of the Application have been consummated. XO Missouri and ALGX Missouri no longer exist as corporate entities – XOCS now holds the telecommunications authorization in Missouri and is now serving the former customers of XO Missouri and ALGX Missouri.

As described in the Application, the corporate reorganization has been transparent to customers as they are currently continuing to receive the same services pursuant to the same rates, terms and conditions. To that end, and in accord with the Commission's October 28, 2004 Order: (1) ALGX Missouri customers were notified of the transaction in October 2004, at least 30 days prior to the merger; (2) XOCS has filed a revised tariff with the Commission, which became effective February 16, 2005; and (3) XOCS hereby notifies the Commission that the directives of the Order have been completed and,
