 - ii. Page 22, Paragraph 45, 3rd line: "Gordon Evans units 3 and 4; and Murray Gill – units 1 and 2" should instead read, "Gordon Evans – units 1 and 2; and Murray Gill – units 3 and 4";
 - iii. Appendix H, Merger Commitment 8, page 3 of 16: "Gordon Evans (units 3 and 4) and Murray Gill (units 1 and 2)" should instead read, "Gordon Evans (units 1 and 2) and Murray Gill (units 3 and 4)"

- b. <u>Ives Direct Testimony</u>
 - i. Schedule DRI-1, Merger Commitment 8, page 3 of 16: "Gordon Evans (units 3 and 4) and Murray Gill (units 1 and 2)" should instead read, "Gordon Evans (units 1 and 2) and Murray Gill (units 3 and 4)"
- 2. These errors resulted from transposing unit numbers and do not affect merger

savings.

WHEREFORE, Applicants request the Commission accept this Errata and incorporate the corrections detailed into both the Application and Ives Direct Testimony as filed on August 31, 2017.
