STAFF RECOMMENDATION

COMES Now the Staff of the Missouri Public Service Commission and for its recommendation states:

1. On November 25, 2009, Mid-Missouri Telephone Company of Pilot Grove, Missouri filed an application with the Missouri Public Service Commission requesting authority to establish a minimum depreciation rate of 6.67% for Account 2212, Digital Circuit Equipment, and to record depreciation expense at a rate of 20.0% for a period of five years beginning January 1, 2010, in excess of such minimum rate pursuant to Section 392.280.2 RSMo 2000.

2. According to its application, Mid-Missouri purchased and placed into service a Lucent 5ESS CDX (5ESS) central office switch in 1997, and proposes to retire the 5ESS switch on December 31, 2009. Mid-Missouri plans to replace it with a Metaswitch MG 3510, which is compatible with fiber and expected to allow the Company to provide advanced services and more robust services.

3. Section 392.280.2 RSMo provides that a telecommunications company may request the Commission to authorize minimum depreciation rates in lieu of fixed rates, and to record depreciation expense on the basis of depreciation rates in excess of such minimum rates. Section 392.420 RSMo Supp. 2008 permits a telecommunications company such as Mid-Missouri to elect to not be subject to the §392.280. Although Mid-

Missouri has elected waiver pertaining to other rules and statutory provisions, it has not elected a waiver of §392.280.

4. As noted in Attachment A, the Staff recommends that the Commission approve the Company's request in this application, as it will allow the Company to remain competitive in the rapidly advancing telecommunications technology.

WHEREFORE, the Staff recommends that the Commission approve Mid-Missouri's application.
