APPLICATION TO INTERVENE OF JEFFERSON COUNTY PUBLIC SEWER DISTRICT

COMES NOW Jefferson County Public Sewer District ("District") and, pursuant to 20 C.S.R. 4240-2.075, files its Application to Intervene, and in support thereof states as follows:

- 1. District is a reorganized common sewer district and political subdivision of the state of Missouri, organized pursuant to the provisions of Chapter 249 of the Revised Statutes of Missouri and reorganized pursuant to section 204.608 RSMo. (2016). District is a political subdivision of the state of Missouri pursuant to section 204.608 RSMo. (2016).
- 2. On June 20, 2000, the Jefferson County Commission, by Resolution and Order 6-20-2000A, determined that the construction of sanitary sewers was necessary for the sanitation, health, safety and welfare of the residents of Jefferson County, proclaimed the sewer district would be known as the "Jefferson County Public Sewer District," and designated the description, size, and location of the District as generally encompassing the entire area of Jefferson County, except for certain incorporated cities with existing sewer systems and areas that the Missouri Department of Natural Resources had designated a sole regional or watershed supplier of wastewater disposal or treatment services, which included Olympian Village.
- 3. On March 29, 2021, Liberty Utilities filed its Notice of Intended Case Filing "with regard to its intended application for a Certificate of Convenience and Necessity ("CCN")

authorizing Liberty to install, own, acquire, construct, operate, control, manage, and maintain a sewer system in Olympian Village, Jefferson County, Missouri."

- 4. The District's interest in this case is different than the interest of the general public in that the District is a continuing authority under the regulations of the Missouri Department of Natural Resources, and by Resolution and Order 6-20-2000A, it has the authority to provide sewer services in Jefferson County in the vicinity of Olympian Village. A conveyance of the sewer treatment facilities from Olympian Village to Liberty Utilities may have an impact on the District's service to the health and public safety interests of the citizens in Jefferson County.
- 5. The District is not currently taking a position on the pending application, but it reserves the right to take a position once the terms of the conveyance are made public.
