PARTIES' PROPOSED PROCEDURAL SCHEDULE

COME NOW the Staff of the Missouri Public Service Commission (Staff) and Vicinity Energy Kansas City, Inc. (Vicinity), through counsel, and submit this proposed procedural schedule, in response to the Commission's March 24, 2022 *Order Rejecting Tariff to Adjust PACC Adjustment Rates*.

1. On February 1, 2020, Vicinity filed two tariff sheets, each bearing an effective date of April 1, 2022, to revise its Production Adjustment Cost Clause (PACC).
2. Staff filed its recommendation March 11, 2022. Staff recommended that the Commission reject Vicinity's proposed tariff sheets and direct Vicinity to file substitute tariff sheets that include the \$731,938 regulatory liability, to be returned to customers between April 1, 2022 and March 31, 2023, subject to prudence review.
3. Vicinity stated on March 18, 2022 that it does not oppose Staff's recommendation.
4. On March 24, 2022 the Commission rejected Vicinity's proposed tariff sheets, suspended the timeline, and ordered the parties to propose a procedural schedule by April 6, 2022. The Commission stated that a prehearing conference would be scheduled in a separate order.
5. The parties propose the following procedural schedule:

Vicinity files substitute proposed tariff sheets and revised Direct Testimony	April 29, 2022
Staff files Rebuttal Testimony ¹ or Recommendation regarding proposed substitute tariff sheets	May 13, 2022
Vicinity files Surrebutal Testimony, if necessary	May 24, 2022
List of Issues, Order of Witness, Order of Cross-examination, if necessary	May 27, 2022
Position Statements, if necessary	June 1, 2022
Evidentiary Hearing, if necessary	June 6, 2022

WHEREFORE, the parties file this proposed procedural schedule for the Commission's consideration and information.
