## ORDER DIRECTING STAFF TO FILE A RECOMMENDATION

On July 15, 2022, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy West) filed a steam tariff sheet (Tracking No. JH-2023-0017) to change the calculation of Evergy West's Quarterly Cost Adjustment (QCA) rider for steam service. The tariff sheet has a proposed effective date of September 1, 2022. The Commission will direct the Staff of the Missouri Public Service Commission to file a recommendation regarding Evergy West's tariff sheet.

### THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation regarding Evergy West's tariff sheet no later than August 11, 2022.
2. Any other party wishing to file a recommendation regarding Evergy West's tariff sheet shall do so no later than August 11, 2022.
3. This order shall be effective when issued.
