On November 9, 2022, the Staff of the Commission (Staff) filed its recommendation for the Commission to approve the tariff sheets (Tracking No. JH-2023-0068) submitted by Evergy Missouri West, Inc. d/b/a Evergy Missouri West (EMW) on October 14, to change the calculation of EMW's Quarterly Cost Adjustment (QCA) rider for steam service. The tariff sheets have a proposed effective date of December 1. A deadline will be set for any party to file a response to Staff's recommendation.

**THE COMMISSION ORDERS THAT:**

1. Any party wishing to respond to Staff's recommendation shall do so no later than November 17, 2022.
2. This order shall be effective when issued.
