ORDER MODIFYING PROCEDURAL SCHEDULE

On October 8, 2008, Northeast Missouri Rural Telephone Company filed a motion asking the Commission to modify the procedural schedule for this case. NE Rural explains that the modification is needed to allow the parties additional time to negotiate before filing testimony. The motion represents that the other parties, AT&T Corporation, the Office of the Public Counsel, and the Staff of the Commission, agree to the proposed modification of the procedural schedule. Since all parties accept the proposed modification to the procedural schedule, the Commission will grant NE Rural's motion.

¹ The motion calls for rebuttal testimony to be filed on November 28, but that is the day after Thanksgiving and state offices will be closed. Therefore, the filing date has been moved to the following Monday.

² The motion calls for the list of issues to be filed on January 18. That is a Sunday. Monday the 19th is Martin Luther King Holiday. Therefore, the filing date has been moved to Tuesday, January 20.

³ Because the filing date for the list of issues was moved to January 20, this date was moved back a day to January 23.
