## MOTION FOR LEAVE TO AMEND BY INTERLINEATION APPLICATION FOR CERTIFICATE OF SERVICE AUTHORITY AND FOR COMPETITIVE CLASSIFICATION

COMES NOW CenturyTel Solutions, LLC ("CTS" or "Applicant"), by its undersigned counsel and, pursuant to Commission Rule 4 CSR 240-2.080(20), respectfully moves the Commission to grant it leave to amend by interlineation its Application for Certificate of Service Authority and for Competitive Classification ("Application") filed herein on August 20, 2003. The Application is being amended to delete Applicant's request for certification to provide basic local exchange telecommunications services within the service areas and exchanges served by CenturyTel of Missouri, LLC and Spectra Communications Group, LLC d/b/a CenturyTel, due to an inability to reach agreement with the Staff of the Commission with respect to this aspect of the Application. This Motion for Leave to Amend by Interlineation withdraws the request of Applicant to receive a certificate of service authority to provide basic local exchange telecommunications services within the service areas and exchanges of CenturyTel of Missouri, LLC and Spectra Communications Group, LLC d/b/a CenturyTel, without prejudice to the

subsequent re-filing of such a certification request at any time in the future. In support of this Motion, CTS respectfully states as follows:

- 1. The first sentence of Paragraph 4 of the Application is amended to read as follows: "CTS seeks authority to provide competitive facilities-based and resold basic local exchange telecommunications services to residential and business customers throughout all exchanges served by Southwestern Bell Telephone, L.P., d/b/a SBC Missouri and Sprint Missouri, Inc. d/b/a Sprint (collectively referred to herein as "ILEC exchanges")."
- 2. Exhibit 2, ILEC Exchanges, is amended by deleting the two (2) pages titled "Exchanges served by CenturyTel" and "Exchanges served by Spectra."

WHEREFORE, CenturyTel Solutions, LLC respectfully requests that the Missouri Public Service Commission grant it leave to amend its Application for Certificate of Service Authority and for Competitive Classification as specifically set forth herein.
