ORDER APPROVING PGA TARIFF

Issue Date: May 31, 2017

Effective Date: June 1, 2017

Laclede Gas Company d/b/a Missouri Gas Energy ("MGE") filed a tariff¹ to reflect changes in MGE's Purchased Gas Adjustment ("PGA") as a result of estimated changes in the cost of natural gas. In addition to an amount for an actual cost adjustment ("ACA"), the tariff will increase the PGA rate for residential sales to \$0.56934 per hundred cubic feet ("Ccf") from the current PGA rate of \$0.49492 per Ccf, an increase of \$0.07442 per Ccf, which represents an increase of \$1.28 per month for the average residential customer. The tariff bears a proposed effective date of June 1.

The Commission's Staff ("Staff") filed its recommendation.² Staff recommends approving the tariff on an interim basis, subject to refund, pending final decisions in related cases on the ACA account balance.

Based on the verified filings,³ the Commission will approve the tariff as Staff recommends. Further, because Laclede's PGA Clause allows for PGA change filings to

take effect on 10 days' notice, the Commission will order the tariff to become effective on less than 30 days' notice.⁴

THE COMMISSION ORDERS THAT:

1. The tariff assigned tracking no. YG-2017-0240 is approved, on an interim basis and subject to refund, to become effective on June 1, 2017. The tariff sheet approved is:
