**SECOND ORDER DIRECTING LIBERTY UTILITIES TO FILE INFORMATION  
REQUIRED BY STATUTE AND REGULATION**

Issue Date: July 10, 2018

Effective Date: July 10, 2018

The Commission approved a stipulation and agreement on June 6, 2018, effective June 16, 2018, that allowed Liberty Utilities to modify its rates for natural gas service. Section 393.275.1, RSMo 2016, requires the Commission to notify the governing body of each city or county imposing a business license tax of any authorized tariff increases exceeding seven percent. Commission Rule 4 CSR 240-10.060 requires Liberty Utilities to file certain specified information about its rate increase and its effect on cities and counties imposing a business license tax at the time it files its compliance tariff. It did not do so. On June 20, the Commission ordered Liberty Utilities to file the required information by July 6. Liberty Utilities has not done so.

**THE COMMISSION ORDERS THAT:**

1. Liberty Utilities shall file the information required by Section 393.275.1, RSMo 2016, and Commission Rule 4 CSR 240-10.060 no later than July 18, 2018.

2. This order shall be effective when issued.
