On December 15, 2021, the Staff of the Commission (Staff) filed its recommendation regarding Ameren Missouri's Actual Cost Adjustment filing. Staff expressed some concerns, comments, and recommendations which were set forth in the Reliability Analysis and Gas Supply Planning section, and also the Hedging section of Staff's memorandum. Thus Staff has recommended the Commission order Ameren Missouri to respond within 30 days to Staff's concerns, comments, and recommendations included in the Staff's recommendation and memorandum.

The Commission will direct Ameren Missouri to respond.

1. No later than January 18, 2022, Ameren Missouri shall respond to Staff's comments, concerns, and recommendations as described in the body of this order.
