COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for its *Recommendation for Adoption Notice Tariff Sheet* hereby states:

1. On September 14, 2020, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities or Liberty (“Liberty”) submitted an adoption notice tariff sheet to be effective October 16, 2020. On September 17, 2020, the Commission ordered Staff to file a recommendation regarding the tariff sheet.

2. Staff reviewed the adoption notice tariff sheet and finds it to be in compliance with Commission Rule 20 CSR 4240-2.060(5)(C). Thus, Staff recommends the Commission approve the adoption notice tariff sheet filed on September 14, 2020.
