## **ORDER GRANTING LEAVE TO APPEAR**

On December 9, 2003, the Missouri Public Service Commission opened a case and set the matter for prehearing conference. A number of entities were joined as parties, including Missouri Gas Company, LLC, Missouri Pipeline Company, LLC and Omega Pipeline Company, LLC f/k/a Omega Pipeline Company. On January 7, 2004, Tino M. Monaldo filed a request for leave to appear.

In the request, Tino M. Monaldo states that he is a member of good standing of the state bar of Kansas. He also states that he is not disqualified to appear in any court. Jeffrey A. Keevil, a Missouri attorney in good standing, is designated as associate counsel. Also, on January 7, 2004, Jeffrey A. Keevil entered his appearance in this matter as an attorney of record.

Commission Rule 4 CSR 240-2.040(3)(C), concerning practice before the Commission, states as follows:

Any attorney who is not a member of the Missouri Bar, but who is a member in good standing of the bar of any court of record may petition the commission for leave to be permitted to appear and participate in a particular case under all of the following conditions:

(1) The visiting attorney shall file in a separate pleading a statement identifying each court of which that attorney is a member and certifying that neither of the attorney's firm is disqualified to appear in any of these courts,

(2) The statement shall designate some member in good standing of the Missouri Bar having an office within Missouri as associate counsel, and

(3) The designated Missouri attorney shall simultaneously enter an appearance as an attorney of record.

The Commission finds that Tino M Monaldo has complied with Commission Rule 4 CSR 240-2 040(3)(C) and will grant the requested relief.

**IT IS THEREFORE ORDERED:**

1 That Tino M Monaldo is granted leave to appear in this matter before the  
Missouri Public Service Commission

2 That this order shall become effective on January 23, 2004

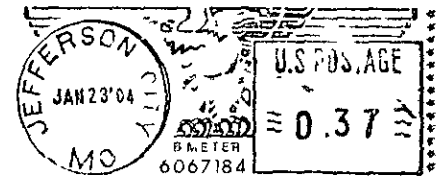
