- 1. My name is Mark L. Oligschlaeger, and I am a Regulatory Auditor within the Missouri Public Service Commission's Auditing Department.
- 2. A margin rate audit of Missouri Gas Utility, Inc. (MGU or Company) called for in the Stipulation And Agreement in Case No. GO-2005-0120 has recently been performed by Staff under my supervision. I am personally familiar with the details of the audit and the statements contained herein. MGU is owned by CNG Holdings, Inc. (CNG).
- 3. Staff's audit of MGU was based upon financial data for the first six months of calendar year 2005. The audit was largely based upon per book numbers, although customer growth revenues, payroll expense and pension expense were annualized by Staff. In addition, customer growth, payroll expense, pension expense and rate base were updated through September 2005.
- 4. Staff's audit of MGU shows that the Company is under-earning by approximately \$60,000 based upon a rate base of approximately \$2.57 million and a rate of return of 5.66% (return on equity of 10.50%). Staff's audit results are based upon the capital structure and debt cost rates of total company CNG. If MGU specific information was used to develop the rate of return in this revenue requirement calculation, then the indicated amount of MGU's under-earnings would be significantly greater than \$60,000.
- 5. The magnitude of MGU's under-earnings, as calculated in this audit, are such that more detailed audit procedures and analysis would be unlikely to result in a finding that MGU is materially over-earning as a result of its margin rates at the current time.
- 6. Staff's audit findings have been provided to the Office of the Public Counsel. The Office of the Public Counsel has indicated to Staff that it will not perform any additional inquiries on this matter beyond the work already performed by Staff in this audit.
