STAFF'S RESPONSE TO ORDER

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for its *Response to Commission Order*, states Staff supports approval of the revised tariffs filed by Southern Union Company d/b/a Missouri Gas Energy (MGE), and further states:

- 1. On April 25, 2011, Staff submitted its *Recommendation* to the Commission on MGE's Infrastructure System Replacement Surcharge (ISRS).
- 2. On April 26, 2011, MGE filed its *Notice of Agreement*, informing the Commission that MGE accepts and is in agreement with Staff's April 25, 2011 *Recommendation*.
- 3. On May 11, 2011, MGE filed a proposed tariff sheet, P.S.C. MO No. 1 <u>Twelfth Revised</u> Sheet No. 10, cancelling P.S.C. MO. No. 1 <u>Eleventh Revised</u> Sheet No. 10, assigned Commission tracking No. YG-2011-0563. MGE also filed a *Motion for Expedited Treatment* seeking the Commission authority for the proposed tariff sheet to go into effect on June 10, 2011.
- 4. On May 11, 2011, the Commission issued an *Order Determining ISRS Amounts*, *Rejecting Tariffs*, *and Directing the Filing of Tariffs*. This Order authorized MGE to establish an ISRS to recover annual revenue of \$3,308,062.

5. On May 11, 2011, the Commission issued an *Order Directing Filing*, directing Staff to file recommendation no later than May 17, 2011.

6. Staff has examined MGE's revised substitute tariff sheets as listed in paragraph 3 and recommends approval of the revised tariff sheet as in compliance with the Commission's *Order*. See Attached *Affidavit Of Michael Ensrud*.

WHEREFORE, Staff supports the revised tariff sheet filed by MGE in Tariff File No. YG-2011-0563 and recommends approval of this tariff sheet, as set out below:
