ORDER CANCELING CERTIFICATE

Issue Date: December 9, 2014

Effective Date: December 19, 2014

This order cancels the private pay telephone certificate of Innovative Businesses and Services, Inc.

On November 14, 2014, the Staff of the Missouri Public Service Commission filed a motion requesting Innovative Businesses and Services' certificate to provide private pay telephone service in the State of Missouri be canceled.

In Case Number TA-97-37, the Commission granted Innovative Businesses and Services a certificate of service authority to provide private pay telephone service in the State of Missouri via customer-owned coin-operated telephone equipment.

Staff's motion states that they were unable to contact the company and believes the company is no longer providing telecommunications services in Missouri. Innovative Businesses and Services also failed to file an annual report or pay any assessment to the Commission.

On November 17, 2014, the Commission issued an Order Establishing Time to Respond to Motion allowing anyone to file a response or request a hearing to do so no later than December 1, 2014. No responses were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the private payphone certificate granted to Innovative Businesses and Services, Inc., shall be canceled.

THE COMMISSION ORDERS THAT:

1. The private payphone certificate granted to Innovative Businesses and Services, Inc., in Case Number TA-97-37, is canceled.
2. This order shall become effective on December 19, 2014.
3. This case may be closed on December 20, 2014.




