

the homeowners themselves or under their direction and supervision.”² The Manager wants to present live testimony by two or three homeowners to rebut Mr. Brune’s testimony that they wanted to be responsible for setting up their homes and that they supervised the installations. This testimony was not developed until after the due date for rebuttal testimony. For this reason, the Manager requests an expedited prehearing conference to determine how this testimony may be received.
