Comes now, Lake Region Water & Sewer Company, f/k/a/ Four Seasons Water & Sewer Company, by and through its attorney of record, Thomas E. Loraine of the law firm of Loraine & Associates, and for its motion pursuant to 4 CSR 240-10.080(8), respectfully states as follows:

1. Lake Region is both a "water corporation" and a "sewer corporation" regulated by the Missouri Public Service Commission ("Commission") as those terms are defined in § 386.020 RSMo 2003.
2. Pursuant to 4 CSR 240-10.080(5), its annual report for water & sewer operations for 2003 is due April 15, 2004.
3. Due to Accountant for Lake Region has recently undergone major surgery and will be out of the office for an extended period of time, Lake Region believes it will not be able to meet the May 15, 2004 filing deadline. Lake Region believes it will be able to file its 2003 Annual Report on or before June 30, 2004.


