On March 23, 2006, Union Electric Company, d/b/a AmerenUE, filed a Motion for Expedited Treatment with regard to its tariff filing, Tariff No. YG-2006-0730. The motion stated that AmerenUE had previously revised its tariff effective March 1, 2006, to move from a monthly commodity price index to a daily commodity price index as the basis for imbalance charges for transportation customers. However, because schools that participate in an aggregation service are cashed out on a monthly basis and because Section 393.310, RSMo Cum. Supp. 2005, does not allow AmerenUE to install the metering necessary for daily metering, the revision was inappropriate for those customers. AmerenUE requested that the Commission approve the tariff sheets such that the tariff will become effective no later than March 31, 2006, so that the cash-out may occur on a monthly basis as it normally does.

On March 24, 2006, the Staff of the Missouri Public Service Commission filed its recommendation. Staff reviewed the tariff submitted by AmerenUE and recommended that the Commission approve it as submitted. Staff also stated that it believes that the need to

properly bill participating school districts constitutes good cause for allowing the proposed tariff to go into effect by the requested date. No other responses to AmerenUE's motion were received.

The Commission has reviewed the tariff and Staff's recommendation and finds that the tariff sheet should be approved. The Commission has also reviewed the motion for expedited treatment and finds that good cause exists under Section 393.140(11), RSMo 2000, to expedite the effective date of the tariff. Therefore, the Commission will approve this tariff to become effective on March 31, 2006.

IT IS ORDERED THAT:

1. The Motion for Expedited Treatment filed by Union Electric Company, d/b/a AmerenUE, on March 23, 2006, is granted.

2. The tariff sheet filed by Union Electric Company, d/b/a AmerenUE, on March 23, 2006, and assigned tariff number YG-2006-0730, is approved to become effective on March 31, 2006. The tariff approved is:
