ORDER GRANTING REQUEST FOR EXPEDITED TREATMENT AND APPROVING TARIFF

Background

On October 21, 2010, Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") filed a proposed tariff to implement revisions to its "Missouri Energy Efficient Natural Gas Equipment and Building Shell Measure Rebate Program" ("Rebate Program"). The revisions involve the funding of the program and how the funds are allocated. The tariff was assigned tracking number JG-2011-0211 and it had an effective date of November 20, 2010. On November 2, 2010, the Office of the Public Counsel ("Public Counsel") filed several pleadings in association with the proposed tariff. Ultimately, the tariff was withdrawn and a hearing was set.

On December 9, 2010, Ameren Missouri filed notification that: (1) the issues surrounding the Rebate Program for 2010 have been resolved; (2) it resumed taking rebate applications; and (3) it has committed to additional funding. Ameren submitted a tariff to reflect the changes to the program, and has requested expedited approval of the tariff because the tariff is for its 2010 program. Ameren asserts that the current changes have

been approved by the other members of the Residential and Commercial Customer Energy Efficiency Collaborative, all of whom are parties to this action. The new tariff sheets, filed under Tracking No. JG-2011-0293, bear an effective date of January 8, 2011, but Ameren Missouri is requesting they be approved to take effect on December 16, 2010.

Having reviewed all of the pleadings in this matter and the newly submitted unopposed tariff sheets, the Commission finds Ameren Missouri's Request to be reasonable and will grant it. Because the tariff is necessary for the 2010 program, the Commission finds good cause to expedite the effective date of the tariff.

THE COMMISSION ORDERS THAT:

1. Union Electric Company d/b/a Ameren Missouri's request for expedited treatment is granted.

2. The tariff submitted under Tariff File No. JG-2011-0293, on December 9, 2010, by Union Electric Company d/b/a Ameren Missouri, bearing an effective date of January 8, 2011, is approved to become effective on December 16, 2010. The specific tariff sheets approved are:
