## ORDER SETTING PROPOSED PROCEDURAL SCHEDULE AND EVIDENTIARY HEARING

Effective Date: August 16, 2011

The parties have filed a proposed schedule as follows:

Company Direct Testimony	August 10, 2011
Rebuttal Testimony	September 8
Surrebuttal	September 21
Issues & Witness List	September 23
Position Statements	September 26
Evidentiary Hearing	October 5
Post-Hearing Briefs	October 27

The parties have also agreed on the following:

1. The initial response time for all data requests is 10 calendar days to provide the requested information, and 5 business days to object or notify that more than 10 calendar days will be needed to provide the requested information.
2. After non-company rebuttal testimony is filed, the response time for all data requests will be 5 business days, beginning the day rebuttal testimony is filed.
3. Parties will provide a copy of all data requests questions sent to all other parties to this case.

The Commission has suspended the tariff until November 5, 2011. The parties propose to submit post hearing briefs by October 27. The Commission must then issue a Report and Order approving or rejecting the tariff no later than November 4. This schedule

leaves very little time for the Commission to consider the parties' post-hearing arguments. The Commission will therefore shorten the time for post-hearing briefs and, to facilitate the parties' efforts, expedite the transcript to be available on October 7, 2011. With this, the Commission may not find it necessary to further suspend the tariff.

Considering the above, the Commission will approve the proposed procedural schedule, the conditions regarding data requests and will set an evidentiary hearing.

**THE COMMISSION ORDERS THAT:**

1. With the exception of the date by which post-hearing briefs shall be filed, the proposed procedural schedule and conditions regarding data-requests are approved.
2. Post-hearing briefs shall be filed on October 17, 2011.
3. The Missouri Public Service Commission shall hold an evidentiary hearing on October 5, 2011 at 9:00 a.m. in room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This building meets accessibility standards required by the Americans with Disabilities Act. 4. This order shall become effective upon issuance.
