**ORDER DIRECTING NOTICE AND
SETTING TIME FOR RESPONSE**

On August 2, 2017, Laclede Gas Company (Laclede) filed a motion to withdraw and cancel the tariffs of Fidelity Natural Gas Company (Fidelity). Laclede explained in its motion that it obtained a certificate to provide natural gas service in the service areas previously served by Fidelity. Laclede also adopted Fidelity's tariff as a temporary measure until Laclede's next rate case. As part of the approved stipulation and agreement in Laclede's following rate case, File No. GR-2007-0208, Laclede agreed to request the withdrawal of the Fidelity tariff. Thus, this filing was made.

Laclede indicates that the Staff of the Missouri Public Service Commission and the Office of the Public Counsel have both indicated that they have no objection to the withdrawal and cancellation of the tariffs. The Commission will give notice and an opportunity to respond to the motion.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall send the parties to Commission File No. GR-2007-0208 a copy of this order.
2. Any request for intervention or response to the motion to withdraw and cancel the tariffs of Fidelity Natural Gas Company shall be filed no later than August 14, 2017.

3. This order shall be effective when issued.




