ORDER CANCELING CERTIFICATE

Issue Date: May 30, 2013

Effective Date: June 9, 2013

On May 17, 2013, the Staff of the Missouri Public Service Commission filed a motion requesting CLEC, Inc. ("CLEC") certificate of service authority and accompanying tariff to provide basic local telecommunications services, non-switched local exchange telecommunications services restricted to dedicated private line services, and interexchange telecommunication services in the State of Missouri be cancelled.

In File Number LA-2006-0274, the Commission granted CLEC a certificate of service authority to provide basic local telecommunications services, non-switched local exchange telecommunications services restricted to dedicated private line services, and interexchange telecommunication services in the State of Missouri.

Staff states in its motion that CLEC contacted Staff via letter stating CLEC was no longer providing service in Missouri and requested the Commission cancel CLEC's certificate of service authority. Staff notes that CLEC is current in the payment of their fiscal year assessments and the submission of their annual reports. Staff recommends that the Commission cancel the company's certificate of service

authority to provide basic local telecommunications services, non-switched local exchange telecommunications services restricted to dedicated private line services, and interexchange telecommunication services.

On May 17, 2013, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than May 28, 2013. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”


Based on Staff’s motion, the Commission finds that the certificate of service authority granted to CLEC, Inc., shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide basic local telecommunications services, non-switched local exchange telecommunications services restricted to dedicated private line services, and interexchange telecommunication services granted to CLEC, Inc., in File Number LA-2006-0274, is canceled.

2. This order shall become effective on June 9, 2013.
3. This case may be closed on June 10, 2013.
