JOINT MOTION TO CONSOLIDATE

Comes now The Empire District Electric Company ("Empire") and Westar Generating, Inc. ("WGI"), by and through their respective counsel, and for their Joint Motion to Consolidate the above-referenced cases pursuant to 4 CSR 240-2.110(5), respectfully state as follows:

- Empire filed what has been docketed as Case No. EM-2000-145 on August 13,
 WGI filed what has been docketed as Case No. EA-2000-153 on August 17, 1999.
- 2. Both cases arise from an agreement entered into between those parties regarding construction of additional electric generating facilities at Empire's State Line facility in Jasper County, Missouri. In general, Empire's case asks Commission permission to transfer certain interests in utility property to WGI pursuant to the agreement. In general, WRI's case asks the Commission to grant WGI a certificate of convenience and necessity for its operation of the

transferred facilities.

- 3. 4 CSR 240-2.110(5) provides that "When actions pending before the Commission involve related questions of law or fact, the Commission may order a joint hearing of any or all the matters in issue, and may make other orders concerning proceedings before it to avoid unnecessary costs or delays."
- 4. Empire and WGI jointly submit that these two cases involve common questions of fact since they arise from the same contractual document and the same generating facility. There may be common questions of law arising from these facts also. So that Empire may avoid the expense of intervening in WGI's case, and WGI avoid the expense of intervening in Empire's case, and to promote the efficiency of other parties, such as the Staff, being able to deal with both cases simultaneously, Empire and WGI jointly move that these cases be consolidated for all purposes.

WHEREFORE, Empire and WGI request an order from the Commission consolidating both referenced dockets for all purposes.
