- 1. SBC Missouri will not originate traffic and send it through ICG under the amended Agreement for termination to any member of either the Small Telephone Company Group ("STCG") or the Missouri Independent Telephone Company Group ("MITG").³
- 2. ICG will not originate traffic and send it through SBC Missouri under the amended Agreement for termination to any member of either STCG or MITG.
