## TCG KANSAS CITY'S APPLICATION FOR APPROVAL OF AN INTERCONNECTION AGREEMENT AMENDMENT

TCG Kansas City, <sup>1</sup> pursuant to Section 252(e) of the Telecommunications Act of 1996 (the "Act") and 4 CSR 240-3.513(6)(C), respectfully submits its Application for Approval of an Interconnection Agreement Amendment ("Amendment" by and between TCG Kansas City and AT&T Missouri, <sup>2</sup> and requests that the Missouri Public Service Commission ("Commission") approve the Agreement.

In support of this Application, TCG Kansas City states:

1. TCG Kansas City is a Delaware corporation with its principal office at One AT&T Way, Bedminster, New Jersey, 07921. It may be contacted at the electronic mail address, facsimile and telephone numbers of its attorneys, as set out under the signature block of this Application. TCG Kansas City is authorized to do business in Missouri.<sup>3</sup> TCG Kansas City is a "local exchange telecommunications company" and a "public utility," and is duly authorized to provide "telecommunications service" within the State of Missouri, as each of those phrases is defined in Section 386.020, RSMo. 2000.

- 3. TCG Kansas City has no pending actions or unsatisfied final judgments or decisions against it from any state or federal agency or court, which involves retail customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of this application.
- 4. TCG Kansas City does not have any annual report or assessment fees that are overdue.
- 5. TCG Kansas City seeks approval of this Amendment pursuant to Section 252(e)(1) of the Telecommunications Act of 1996 ("the Act"). The Amendment, which amends the parties' Interconnection Agreement approved by the Commission on November 28, 2007 in Case No. CK-2008-0109, clarifies certain limitations to TCG Kansas City's access to the pre-order functions of AT&T Missouri's Operations Support Systems ("OSS"). The Commission must approve the Amendment unless it determines that the Amendment (or any portion thereof): (1) discriminates against a telecommunications carrier not a party to the Amendment; or (2) the implementation of such Amendment is not consistent with the public interest, convenience, and necessity.<sup>4</sup>
- 6. TCG Kansas City states that the Amendment does not discriminate against a telecommunications carrier not a party to the Amendment. TCG Kansas City further states

# AMENDMENT TO INTERCONNECTION AGREEMENT BY AND BETWEEN SOUTHWESTERN BELL TELEPHONE COMPANY d/b/a AT&T MISSOURI AND TCG KANSAS CITY, INC.

Pursuant to this Amendment, (the "Amendment"), Southwestern Bell Telephone Company d/b/a AT&T Missouri ("AT&T Missouri") and TCG Kansas City, Inc. ("CLEC"), (collectively referred to as the "Parties"), hereby agree to amend that certain Interconnection Agreement between the Parties dated August 21, 2007 (Agreement).

WHEREAS, AT&T Missouri and TCG Kansas City, Inc., entered into the Agreement on August 21, 2007, and;

**NOW**, **THEREFORE**, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

- 1. The Parties agree that Section 3.3 of the OSS Appendix of the Agreement is deleted in it entirety and replaced with the following:
  - 3.3 Within <u>AT&T-13STATE</u> regions, CLEC's access to pre-order functions described in 4.2.2 will only be utilized to view Customer Proprietary Network Information (CPNI) of another Carrier's End User where CLEC has obtained an authorization from the End User for release of CPNI. Nothing in this Appendix shall be interpreted to prohibit CLEC from accessing its own CSR data or the CSR data of its affiliates (where requisite permission has been obtained) for any purpose permitted under law.
- 2. All of the other provisions of the Agreement, dated August 21, 2007, shall remain in full force and effect.
- 3. This Amendment shall be filed with and is subject to approval by the Missouri Public Service Commission and shall become effective ten (10) days following approval by such Commission.
- 4. In entering into this Amendment, neither Party waives, and each Party expressly reserves, any rights, remedies or arguments it may have at law or under the intervening law or regulatory change provisions in the underlying Agreement (including intervening law rights asserted by either Party via written notice predating this Amendment) with respect to any orders, decisions, legislation or proceedings and any remands thereof, which the Parties have not yet fully incorporated into this Agreement or which may be the subject of further review.
